**January 29<sup>th</sup>, 2023**

Call to Order by Pres. Phil Stegemoeller

- Approval of the minutes of the previous annual meeting **M/S/P**
- Phil discussed the new accrual accounting process being used by the Council for the budget. All income and expenses are reported in the month that they occur and not waiting for an actual invoice to record an expense.
- Phil reviewed the budget for 2023 and answered a question about Pastor's salary. Tara had found that we had been under paying the Pastor for a few years, so there is a slight jump. Phil invited recommendations and ideas for saving money.
- All the committee reports are in the annual report.

Darrell gave the report on endowment.

- Last year Endowment paid \$288,120.93 toward the stained glass windows.
- \$26,680 was paid for the sound system.
- At present \$251,492 in the main fund at Thrivent.
- Proposed 2023 budget is \$12,000.

Suzan reported on Outreach.

- Chaplains on the Harbor have been unable to find a place for the cold weather shelter, so keep them in your prayers.
- Consultation to Clergy did over 40 interviews. Lauren will give report to the Pastor and the council. Next step will be Congregation Assembly for constructive communication about what we want our congregation to be. Naomi suggested that this become a regular process for the congregation.

## **PRESIDENT'S REPORT – 2023**

2023 has been a time to break down and a time to build up for Amazing Grace.

In February we received Pastor Laurin Vance's first report based on his interviews of the congregation. His interviews brought up many concerns, including a lack of clarity about the mission of AGLC, the decision-making process, and unresolved conflict. The congregation then participated in a listening session facilitated by Pastor Laurin. Those who participated found it very meaningful to hear each other and to be heard. Pastor Laurin also facilitated another meeting in August to help us walk through the discussion of moving pews in the sanctuary.

Pastor Laurin has guided us through a process where everyone was heard, and their opinions valued.

Your Church Council has taken Pastor Laurin's report about the lack of clarity very seriously. It is on our minds during every discussion at every Council Meeting. We are committed to doing a better job of communicating and listening.

Also, during this time of transition, we have been guided by the Synod on the process. We appreciate the thoughtful advice from the Bishop's associate, Rebecca Shjerven. We had a fulfilling farewell for Pastor Val, with an outpouring of love and thankfulness for her years at Amazing Grace. Pastor Rebecca also guided us to Pastor Doug as an interim, to help us through the call process. His years of experience, wisdom, and calm have been helpful in this time of change.

Pastor Shjerven has continued to help in setting up a Transition team. We have been blessed with a strong, committed team that is now in place, busy with the work of clarifying the congregation's mission and completing the Ministry Site Profile. This team will be looking to talk to as many members of the congregation as possible. When they have completed their work, a Call Committee will be formed. The Call Committee will use the information developed by the Transition team to help in calling a Pastor later this year.

During this time of breaking down and building up, the work of fulfilling Amazing Grace's mission has not stopped. Please read all of the reports included in this Annual Report to get the full idea of what a group of wonderful, passionate, and motivated people are called to serve and worship at Amazing Grace. Please consider joining the groups and committees in their work. Always keep your Pastor, the Church Council, PSALM team, and the Transition team in your prayers.

## **ANNUAL VICE PRESIDENT'S REPORT - 2023**

*God has given every human being a gift, or talent, to use for His purpose. "As each has received a gift, use it to serve one another, as good stewards of God's varied grace" (1 Peter 4:10). God wants us to use these gifts to help others and glorify Jesus Christ, not ourselves.*

**The 2023 goal** was to make the Vice President an active working position within council and a co-leader with the President. The constitution has limited write up duties for each position of council chairs, especially the Vice president role. This past year council has had different chairs give a talk in church which included a write up for the SPIRIT on what the congregation thinks they do, what the constitution says they do, and what their position actually is responsible for and what they oversee.

It is well worth having co-leaders to split the duties and manage church business and ministries. Co-leaders have a broader range of gifts and talents to use and can bounce ideas and decisions off each other. The church within society is in a huge transition and it will take strong leadership of all council members to move through AG's transition and move in a direction that is Spirit led. We are committed to prayer and discernment, and listening to all members at this time.

The first six months of this year I worked with Mark and Pastor Val as we continued to access Pastor Laurin Vance. Pastor Val retired from AG and the PSALM team assisted with services until we hired our transitional part-time Interim Pastor Doug Knutson-Keller in September. Due to having a part-time pastor it opened up many jobs around the church which as vice president and a lay minister I was able to fill in.

**An overview but not in detail:**

\* Attend monthly executive board meetings with Mark and Pastor Doug. Attend monthly council meetings.

\* Communicate with Mark and Pastor on Transition Team and Progress. Meet with Pastor and/or Mark as needed.

\* Support and assist council members' ministries when requested to do so.

\*Weekly: Assist Vicky in weekly input, corrections, and review of Sunday bulletins, Grace notes, announcements, and managing incoming e mails as needed. Answer other questions as needed for church business and ministries. Plan and coordinate the worship schedule which includes the presider, preaching, and Young People's Message for Sundays Pastor Doug is not here. Write Sundays Prayers of the People 2 to 3 times a month. Assist Vicky with the monthly SPIRIT.

**Continuing Leadership Education:**

1. Completed a 10-week course on sermon writing through (BSP) Back-Story-Preaching and the Homiletics Festival online through Luther Seminary.
2. Enrolled in the SYNOD 12 session Thriving Leadership Formation (TLF) co-hort group. Runs through April 2024.
3. Attended Zoom meeting with Namibia taskforce. Met Alison Richard, the newly appointed ELCA Chicago leader and Rev. Dr. Themba from Madagascar who is the Regional Rep. for South Africa. There will be a planning conference in Chicago in 2024. My plan is to attend.

A local budget of \$12,000 was approved for 2023. There was a carryover of \$7076 from 2022 for a total budget of \$19,076 for 2023.

On Jan. 20, 2023, a final payment of \$152,198 was sent for the windows project.

There were three in-person meetings during the year in addition to several telephone discussions. The fourth quarter meeting was done by phone as there were no new proposals presented. The expenditures for the year can be viewed on the attached distribution sheet. There are several proposals still pending.

## OUTREACH MINISTRY - 2023

AGLC Outreach Ministry has been active in 2023 serving the needs of people in Grays Harbor and beyond in a variety of ministries.

**Food Banks** — Members continue to generously support both the Aberdeen Food Bank and the Salvation Army Food Bank. Donations are collected from the parish hall baskets and brought to the Food Banks by Joelle Buckman and Greg Johnstone.

**Family Promise** — The main floor of our parish hall continues to be the home of Family Promise of Grays Harbor. Changes due to the pandemic continue to affect how Family Promise is run, but nevertheless, multiple families were provided a safe space to live, and volunteers continue to participate. Darci Jewitt serves as director.

**Chaplains on the Harbor** — We supported COTH this year with prayer for their ministries and cold weather supplies for them to distribute to our unhoused neighbors. We also provided propane in small canisters to help people heat their tents.

**E.L.F. (Elevate Local Families)** — Amazing Grace E.L.F. elves were able to give \$4,650 in gift cards and gifts to 51 local families and 6 young people living at the Youth Shelter. All proceeds from the pie auction in November were donated to this effort. Many thanks to all in the congregation who baked, knitted, and created – and then bid generously at the pie auction to help many families in need at Christmas through E.L.F. Thank you to Amy Ostwald for organizing this ministry and to Gary Morean for serving as auctioneer at the Pie Auction.

**ELCA ‘Good Gifts’** – The ELCA Good Gifts program helps provide families with the means to earn an income through agriculture. Gifts include a flock of chickens for eggs, bees for honey, cows and goats for milk or meat, seeds for planting, etc. Your generosity travels far around the world. Thank you to Debby Colangelo for co-chairing this effort.

**Union Gospel Mission Meals** — Teams continue to provide meals at the mission in Aberdeen on the first Tuesday of each month. Six teams each provide a meal 2x a year for about 50 hungry people. Gratitude for all who participate.

**God’s Work, Our Hands** — In September, 25 members gathered after worship to put together school kits for children around the world who have no access to school supplies. Without supplies they are not fully equipped to attend school. All the supplies were donated by AGL members. Thank you to Eileen Schermer, Arlene Torgeson and members of AGL Quilters for organizing this ministry.

**Undie Sunday** – On December 10 we sponsored our very first Undie Sunday. Members brought an abundance of socks, underwear, and t-shirts to church to be blessed and then distributed to the Union Gospel Mission and Friendship House. Thank you to Tara Main for coming up with this idea and serving as chief organizer. We plan to hold our next Undie Sunday in fall of 2024.

**Sisters in Recovery (SIR)** – This 12-step group has been meeting in our building for many years. The group has grown and was given permission by church council to display their literature rack and conduct monthly potlucks in the AGL fellowship hall. This is outreach on our part in that we so generously share our space and accommodate their schedule. (The group donates a small amount every quarter as a token of gratitude and to honor their tradition of self-support.)

**Other Outreach Ministries** – Salvation Army Kettle Ringing, Coastal Harvest Christmas baskets and Quilters (see their separate report).

**SWW Synod Council and the Namibia Task Force** – I was elected to Synod Council this year and have enjoyed participating in it as well as the Namibia Task Force. These are ways for me to reach out beyond our local area.

I attended two workshops in 2023, one with Debbie Colangelo about housing in Grays Harbor and one by myself about drug addiction in Grays Harbor. Both were very informative and left me with a sense of hope for the future of our area.

I have mentioned very few names in this report. Almost every member of AGL has participated in Outreach this year. We Lutherans are taught by Jesus to be generous. In 2024 we will be evaluating our Outreach ministries as we move forward in our search for a new pastor. I look forward to continuing many if not all our current ministries as well as exploring and beginning new and different options for extending God's love to our neighbors. I ask you to think and pray about what risk-taking mission means to you and our congregation.

## **WORSHIP COMMITTEE - 2023**

### **Worship**

Our congregation experienced a major transition in 2023 with the retirement of Pastor Valyn Metropoulos. Many congregants stepped up to fill the gap during our transition, including the Psalmists, musicians, and worship assistants.

After Paster Doug Knutson-Keller joined us as interim minister in September, we continued to seek out creative and innovative ways to fill our needed pulpit supply, including asking members to speak and teach during service.

Overall, we chose to make minimal changes to our worship service while our congregation works through our ministry transition.

### **Music**

In January, Kris Burns and Hank Bilderback set a goal to raise the necessary money to replace the grand piano in the Sanctuary. After an education session with the piano shop owner from Olympia, a few members set forth with a plan to offer small fundraisers to work towards the goal. Those initial fundraising opportunities sparked a fire and by the end of June, the full amount had been raised, including enough to replace the piano in the Fellowship Hall, as well.

In August, Hank and Kris restarted the church choir to perform at the Window Dedication Celebration in September. The choir has added a joyful noise to our Sunday services and its return has been much appreciated by the congregation.

### Liturgical Arts Team

The Liturgical Arts Team (LAT) met several times throughout the year to change the Sanctuary decorations for the church season. Our group of dedicated volunteers put a lot of time and energy into each season change. Highlights from the past year include the decor during Lent in early 2023 and the end of the year Advent decor that included hand-made banners and a beautiful royal blue paraments that represent our congregations past and our future.

### Altar Guild

The Alter Guild is the silent partner in our worship. Each week, our members set up and clean up communion on Sunday morning. You rarely see them; they rarely need a substitute or forget to set up. I am beyond grateful for their work and consistency in ensuring our communion service happens each week.

### Worship Committee

The Worship Committee consists of the council representative, accompanist, choir director, liturgical arts team representative, psalmists representative. Our current Worship Committee includes Sarah Teveliet Channel, Kris Burns, Hank Bilderback, Dee Erickson, and Diane Hanson.

The Worship Committee met several times this year to discuss questions and concerns brought forth from the congregation. The three major topics discussed this year include funding for the piano replacement, symbol uses in the Sanctuary (crosses, candles, banners, etc), and communion service.

The year started off with Carrie Erwin continuing her Fellowship Chair position. The potluck was held for the Annual Congregational Meeting. Easter Breakfast was put on by the men of the church. Plans were beginning to take shape for our AGLC anniversary highlighting our stained-glass windows, recently refurbished. Then Carrie needed to bow out of her chairmanship. I was appointed to fill in for her and started in March for the remainder of her term which is until Jan. 2024.

For Pentecost Sunday we celebrated at Fellowship Hour with a pinata for the children. The pinata symbolizes the different cultures/languages present that first Pentecost day.

A Fellowship Committee transparency talk was given to the congregation on July 2nd so we could all better understand its purpose. Later that month we planned and celebrated a baby shower for the Steinhauer family. Earlier in the year a baby shower was given for the Fernandez family.

Pastor Val made the decision to retire this year, so a Farewell was held for her in July. It was complete with food, cakes, speeches, gifts and goodwill! Thanks to Kathy Wehage and her group of helpers for making this a memorable occasion.
